BOOKING POLICY

A 50% deposit is required to book a hunt with Ridgeline Outfitters LLC. The balance is due 30 days prior to the hunt.

CANCELLATIONS

If for any reason you have to cancel your hunt, it must be done, in writing, 60 days prior to your hunt. The deposit may be applied to a future hunt.

STATE LICENSE

The cost for a **New Mexico** Non-Resident State License for quality Elk is \$772.00, standard Elk \$547.00, private land Elk \$781.00 quality Deer \$355.00, standard Deer \$270.00, Antelope \$282.00. A \$9.00 Habitat Stamp is required on all licenses. This cost is not included in our prices.

The cost for **Arizona** Non-Resident State License for Elk is \$595.00, Deer \$232.75 and Antelope \$485.00. Arizona requires hunters to purchase a general hunting license to apply for any big game species, that cost is \$151.25 for Non-Resident.

GENERAL INFORMATION

We offer airport pickup and drop off for a minimal fee. Please make prior arrangements for this service. When in camp, we provide a full time cook on fully guided hunts. Meals include breakfast, lunch, snacks, and dinner. There is always plenty to eat. Lodging will consist of a house, cabin, or wall tent. Each hunter will have his/her own bed in the house or tent. Ridgeline Outfitters LLC hunts includes a professional, licensed guide per two hunters. Two hunters per guide can be upgraded to one on one for an additional \$200.00 per day. The guide will be responsible for the field care of the trophy. Land owner permits and licenses are not included in the quoted hunt price.

Ridgeline Outfitters LLC is not responsible for any changes in license fees, hunt dates or any other changes made by New Mexico Game and Fish Department and Arizona Game and Fish Department.

The hunter hereby agrees to hunt with Ridgeline Outfitters, LLC and use Ridgeline Outfitters, LLC exclusively for a guided hunt. Ridgeline Outfitter, LLC agrees to provide their outfitter identification number as part of services, to be used exclusively by Ridgeline Outfitters, LLC.
